4. Decisions Made

1. The Chairperson IQAC read the report of odd semester, IQAC meetings, action plans and status of compliance.
2. The Chairperson welcomed all attendees and emphasised the importance of aligning development initiatives with NAAC quality benchmarks and put forward a proposal to install solar panels in the college under a green energy initiative. After a rigorous discussion the management approved a proposal to install solar panels on campus. The decision aligns with the environmental sustainability goals under NAAC Criterion VII (Institutional Values and Best Practices). This initiative not only aims to reduce the carbon footprint of the campus but also serves as an educational tool for students, fostering a culture of environmental responsibility. The management is committed to monitoring the project's progress and ensuring that it meets the established benchmarks for sustainability.
3. The chairperson informed the administration that the college's auditorium was to be renovated and given a new look. Management sanctioned preliminary funds for assessment and repair planning. Renovation is scheduled to begin soon and be complete before the new academic session begins. The administration is keen to ensure that the enhancements will provide students and faculty with a more modern and comfortable environment for events and lectures.
4. The Chairperson placed the present status of admission for session 2025-26. The Chairperson expressed the need of intensifying the efforts to increase the process of admission. After rigorous discussion, finally it was decided by the management not to raise student fees for the upcoming academic year since it was not in the best interests of applicants from rural areas and those from economically weaker section and admission committee should develop a plan and carry out personal contact with suitable candidates as soon as feasible in order to persuade aspiring students and their parents and also to highlight the performance of the institution.
5. The chairperson told the management about the college football team's formation and their plan for getting more students involved in other sports also. This initiative aims to foster a spirit of teamwork and healthy competition among students while also encouraging greater participation in various sporting activities throughout the academic year. After careful consideration, management and the IQAC members unanimously praised this initiative.
6. IQAC coordinator read the report of odd semester results of all classes. Performance of Sakshi Sharma of M. Com Semester Ist was highly appreciated

by all the members, who is securing 8.36 SGPA and Arman, Rohan of same class got 8.05 and 8.00 SGPA respectively. Roji and Amanjyot Kaur of BA V Semester got 75.50% and 75.25% respectively. Palak, Tanoi and Lovedeep Kaur of B. Com(PC) Sem III is secured 8.14, 8.00, 7.86 SGPA, respectively. Prabhleen Kaur of B. Com FS Semester V secured 78% marks, Amandeep kaur and Sakshi Sharma Secored 77% and 74% marks respectively. In BCA-III Semester, Anmoldeep Singh and Harsh Gulati secured 65% and 64.67% marks respectively. In BCA-V Semester, Bhavna Passi and Arshpreet Singh secured 66.25% and 65.25% marks respectively. Overall, over a dozen students got distinctions in the odd semester results.

Future Plan:

- 1) To expand the infrastructure for providing better facilities.
- 2) expand extracurricular opportunities to develop more clubs, sports facilities and cultural programs to encourage holistic student development and campus engagement.
